### **Resolution adopted by the General Assembly on DD MMMM 202x**

#### **NN/xxx. International Day Affirming Human Dignity for Everyone Everywhere**

*The General Assembly,*

*[PP1]* Recalling the Preamble to the United Nations Charter which proclaims a determination “to reaffirm faith in fundamental human rights, in the dignity and worth of the human person, [and] in the equal rights of men and women”,

*[PP2]* Recalling the Preamble of the Universal Declaration of Human Rights, which declares that “recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world”,

*[PP3]* Recalling Article 1 of the Universal Declaration of Human Rights, which emphasizes that “all human beings are born free and equal in dignity and rights. They are endowed with reason and conscience and should act towards one another in a spirit of brotherhood”,

*[PP4]* Recognizing the inherent human dignity of all individuals,

*[PP5]* Recognizing that respecting, promoting, and protecting human dignity for everyone everywhere is the foundational principle and the key objective of human rights,

*[PP6]* Recalling the 75th anniversary of the Universal Declaration of Human Rights,

*[PP7]* Recalling the 30th anniversary of the Vienna Declaration and Programme of Action,

*[PP8]* Concerned by continuing violations of human rights around the world that severely affect the human dignity of individuals,

*[PP9]* Reaffirming that human dignity has a positive role in the promotion and protection of all human rights,

*[PP10]* Emphasizing that human rights are universal, indivisible, interdependent and interrelated, and stressing the role that human rights play in the promotion and protection of human dignity,

*[PP11]* Recalling that States have the primary responsibility to promote and protect human rights,

*[PP12]* Emphasizing also that States, regional organizations, national human rights institutions, the media, non-governmental organizations, and civil society including religious bodies and faith-based actors as a whole have an important role to play in promoting human dignity and human rights for everyone everywhere,

*[PP13]* Acknowledging the positive contribution of individuals and of relevant civil society organizations to the promotion of human dignity and human rights for everyone everywhere,

*[PP14]* Noting the cooperation between states, the United Nations, international and regional organizations and civil society in the promotion of human dignity for everyone everywhere, and noting also the work of the United Nations Alliance of Civilizations in promoting human rights as a means of promoting human dignity,

*[PP15]* Strongly condemning continuing violations of human dignity and rights and underlining the importance of a comprehensive and inclusive community-based approach involving a wide set of actors, including civil society and religious or belief communities,

*[OP1]* Reaffirms the central role of human dignity in all human rights;

*[OP2]* Designates [June 10] as the International Day Affirming Human Dignity for Everyone Everywhere;

*[OP3]* Invites all Member States, relevant organizations of the United Nations system and other international and regional organizations, as well as civil society, including non-governmental organizations, individuals and the private sector, to observe the International Day in an appropriate manner, within available resources, including with concrete activities at the grass-roots level;

*[OP4]* Requests the Secretary-General to bring the present resolution to the attention of all Member States, the organizations of the United Nations system and civil society organizations for appropriate observance.
